

# Umsong HWC Sectoral Meeting Minutes

Date: 30/06/22

At the very outset BMO Jirang Block,welcomed all the staff who were present at the meeting. The meeting started with the agenda as follows :-

## Home and Institutional Delivery Review:

BPM stresses the need to have the meeting at SC level as most of the headmen cannot attend at CHC or PHC level due to various reasons.He briefs about the purpose of such meetings and the agenda which are needed to be discussed.

BPM shared Home deliveries (8 nos) and Institutional deliveries (1 nos).Nongkynrih, Jalilum were the main contributors of HD.Anm said that PW came for ANC but delivered at Home (Nongbirthem).Nongkynrih headman mention the issues viz poverty and bad roads which is the major reason for PW not being able to come to health facility.BPM thoroughly explained and mentioned about the transit home which is will be set up in Patharkhmah CHC from the CMSMS, especially needed for far flung villages.Briefing on JSSK and CMSMS was also shared for information.

BDM bah D.Binong briefed about the immunization status and emphasized the need for registration of PW in the Mothers App.Anm sis Bate said that those PW who refuse on registration never want to be immunized viz BCG etc.

BDM mentions that child death under 5 years might be under reporting as per his data.BPM informs headmen and all who are present that they can use the Whatsapp group for any kind of information.

Nongladew asha said that they never received any referral transport back home from Nongpoh or even Ganesh Das when referred from patharkhmah.Reason as understood is because of unawareness about JSSK from the indoor staff.BPM said that he will apprise the issue to the higher authorities.

## Upcoming Deliveries:

BPM read the list of upcoming deliveries for the month of June which was always shared on the first week of every month via whats App group with all participants and reminded them to follow up especially the High Risk and to make sure of Institutional Delivery.

## CMSMS :

BMO did a briefing on the guidelines of the Chief Minister Safe Motherhood Scheme and how it will benefit pregnant mothers.

## VHC :

BPM NHM reminded everyone about the formation of VHC by those villages who had received training.He also informed all to use the Jirang Block Website “[jirangblockhealth.info](http://jirangblockhealth.info)“ if they need contact numbers of headmen,AWW,Asha,Gram Sevaks etc.

Sis Bate concluded the meeting with a vote of thanks.

Next meeting was decided to be held at Tasku HWC on the 21st July 2022 at 11 am.
